

EVENT TERMS & CONDITIONS

1. Privacy Policy

Please notify GIRP in writing if you do not wish for us to share your presentation with the participants by email and/or on the GIRP website after the event.

2. Dietary requirements

3. Cancellation of the event

For reasons beyond the control of the organisers, the date, venue, timing and content of the programme (including speakers) may be altered without prior notice. The organisers regret that they cannot accept liability for losses incurred by attendees under these circumstances.

The organisers reserve the right to cancel the event at any time without liability. In these circumstances, participants will be given the opportunity to attend the event on an alternate date, or a full refund. GIRP reserves the right to modify the Event Terms & Conditions without notice.

The organiser shall not be liable or responsible to participant when a delay or cancelation of the event is caused by or results from the following force majeure events ("Force Majeure Events"): (a) acts of God; (b) pandemic, flood, fire, earthquake or explosion; (c) war, invasion, hostilities (whether war is declared or not), terrorist threats or acts, riot or other civil unrest; (d) government order or law; (e) actions, embargoes or blockades in effect on or after the date of registration; (f) action by any governmental authority; (g) national or regional emergency; [(h) strikes, labor stoppages or slowdowns or other industrial disturbances;] [and] [(i) shortage of adequate power or transportation facilities;] [and] [(j) other [similar] events beyond the [reasonable] control of the organiser impacted by the Force Majeure Event.

The organiser shall resume the performance of its obligations as soon as reasonably practicable after the removal of the cause.
